## **Terms & Conditions:**

- 1. The estimated quantity given above is only approximate, which may vary by 20%.
- 2. The tenders should be accompanied with EMDs amounting to Rs. 30,000/- in the shape of FDR/CDR pledged in the name of Chief Accounts Officer, J&K AIDS Control Society.
- 3. Rates offered should be inclusive of all taxes per site etc. and should be valid for a period of 3 months.
- 4. The rates should be quoted for Annual Maintenance Contract (AMC) of Existing Hoardings installed all over the UT of J&K & Leh inclusive of cost of material, printing, installation/replacement of flex or iron rods etc, transportation, loading, unloading, mounting, taxes etc.
- 5. The flex of the hoardings is to be fitted on iron frame.
- 6. In case of damage to hoarding / flex reported from the institution the same shall be repaired / re-fixed within a period of 10 (ten) days, failing which penalty will be imposed.
- 7. The rates quoted by the bidder shall be fixed for the duration of the contract.
- 8. Any tenders deficient or incomplete in any of the requisite matters, particulars or formalities shall be rejected.
- 9. The contents of the material to be displayed will be provided by IEC division of JKACS.
- 10. The tender should be accompanied with of flex sheet A4 size 320GSM.
- 11. The purchaser shall evaluate and compare the tenders to determine the substantial offer. Keeping in view the quality, the committee is not bound to accept the rates of lowest tenderers.
- 12. The work should be completed within a period of one month from the date of issuance of work order.
- 13. No advance payment will be made to the successful tenderer, however 60% of payment will be released in favor of the successful bidder after replacement of flex & its verification by the team of JKSACS as per terms and conditions of the contract, 30% after 6 months and balance payment (10%) will be released after the completion of the contract.
- 14. Purchase committee, reserves the right to modify, cancel or reject any tenders or part thereof without assigning the reason.
- 15. Any other clause, if found necessary in the interest of JKACS shall be entered into and form a part of the contract.
